NORTON-MARCH AIRCREW ASSOCIATION (NMAA) MEMBERSHIP CLASS

FOUNDING MEMBER: Those persons who were stationed at Norton AFB, March AFB, or March ARB, during their time of Service in the U.S. Military and/or U.S. Civil Service; and who joined the NMAA and paid dues any time **during the year of its founding in 2015**; will be considered a **Founding Member** and shall be entitled to participate fully in the Affairs of the Association including holding office and voting privileges.

ACTIVE MEMBER: Those persons who were stationed at Norton AFB, March AFB, or March ARB, during their times of Service in the U.S. Military and/or U.S. Civil Service and who joined the NMAA and who's dues are current will be considered an **Active Member** and shall be entitled to participate fully in the Affairs of the Association including holding office and voting privileges.
